Plans have begun for the Twelfth Annual Christmas Arts & Crafts Show in Cheyenne Oklahoma! This year's craft show will be held on Saturday November 20, 2021 The show will begin at 9:00 AM and end at 4:00 PM. It will be held in the Roger Mills Ag Pavilion.

You may reserve your booth now. Booth space is \$40.00 for an 8x10 space. Payment is non-refundable. Electrical outlets are available on wall space only. Please note on your form if you need an electrical outlet we can make arrangements for you to be near one. Electricity is NOT available in the middle booths. You must provide your own electrical cords.

Booths 19 and 20 are in front of the door so they are available for Saturday setup only. Unpaid booths will not be held. One vendor per booth no booth sharing.

If you have a tent or structure you must choose a space in the west building.

The wall spaces will be filled before the middle booths and we will try to accommodate you but we reserve the right to make final booth assignments. Due to unexpected events it is sometimes necessary to relocate vendor's booths. We reserve the right to relocate vendors if necessary. Please note double booth space 27 has a storage cabinet that can't be removed.

We encourage everyone to bring their own tables and chairs. There are a limited number of tables and chairs available. You must let us know if you would like to use one of our tables. Vendors are responsible for retrieving and setting up the tables and returning them at the end of the show.

The Chamber of Commerce will provide advertising through newspaper ads, social media, flyers, online, Penny News and radio ads. Santa will also be making a visit to the show in the afternoon to pass out treats and visit with the children. This has proved to be a big draw for the show in the past. There will be a concession stand available with homemade goodies and drinks. **No signage may be posted outside of your own booth on doors or by concession.**

We do not allow outside food sales. You may not sell concession type items such as hot dogs, nachos or individual items like brownies, cupcakes, candy etc. . Baked goods, canned goods and packaged homemade candy are allowed.

We are not responsible for vendor's product rules for multiple bookings in our show. We have no restrictions against booths with the same or similar products. If you have such restrictions, please inquire before you book a booth.

We ask that all vendors stay until 4:00 PM closing time. Please do not start packing up your booth until the show has closed. Vendors who close early will not be invited back.

We are dedicated to making our show a successful and rewarding show for everyone involved. We invite you to join us this year and help to make our show one of the best in Western Oklahoma!

We do not provide electrical cords. No electricity is available in the middle spaces.

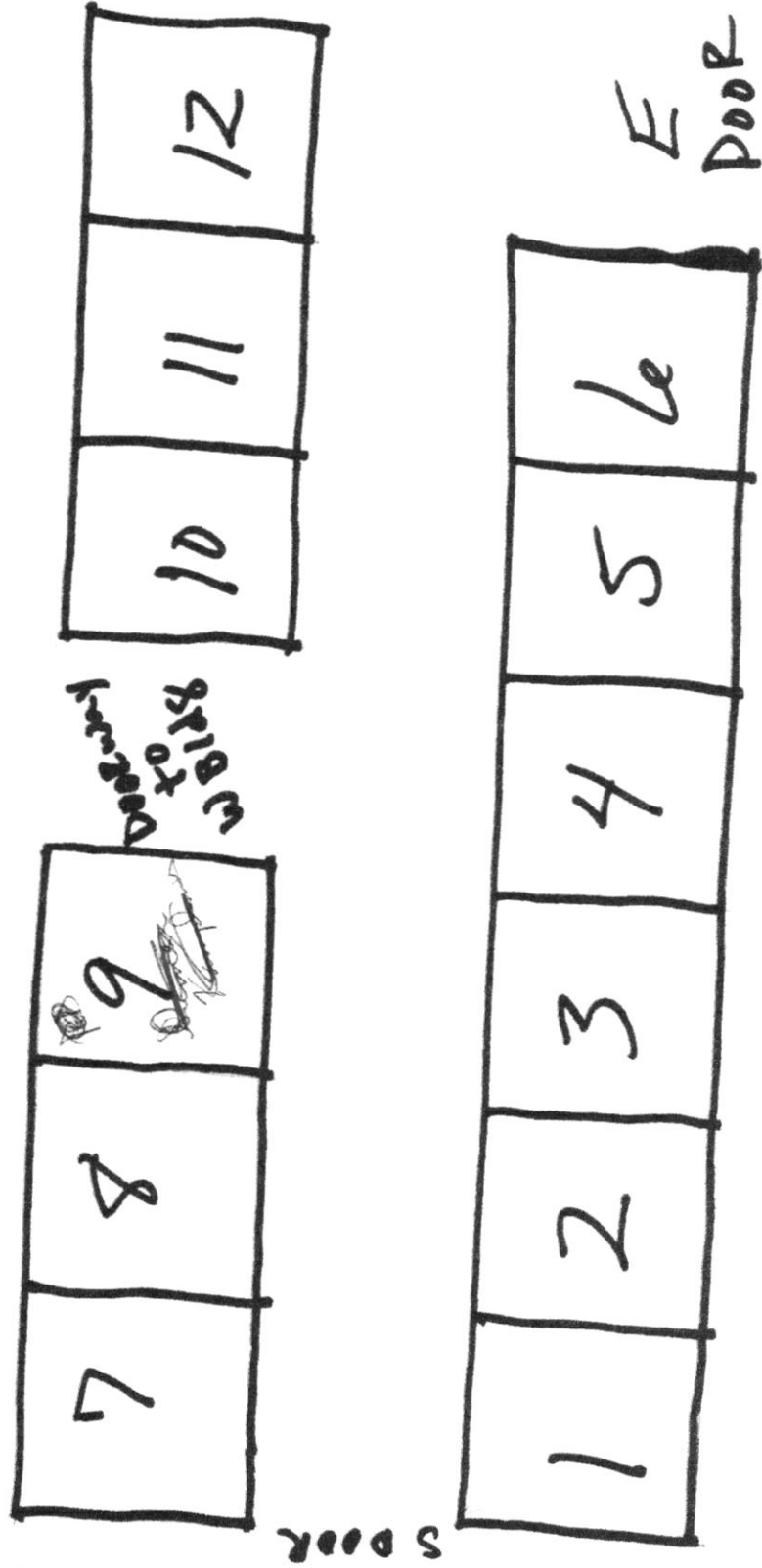
There are tables available in the back. You will have to retrieve and set them up yourself, One Table per booth is allowed. You are responsible for returning the table after the show is over.
